**Thank you** for continuing to support the Union County Foundation in our efforts to help make Union County an even better place to live, work, and raise our families. As you know, 2018 marked our 25<sup>th</sup> anniversary and we are carrying that momentum into 2019.

The number of funds housed at the Foundation has soared to a count of 107! These named funds support everything from arts and culture, health and recreation, seniors and youth, to just about any other positive cause you can imagine.

Last year’s final numbers are in and they tell a wonderful story:

- \$798,814 of total grants were allocated for a wide range of projects.
- \$184,673 in scholarships were presented to graduating Union County high school seniors and special needs youth to attend summer camps.
- 34 awards totaling \$46,951 were distributed through our quarterly application process.
- During our anniversary year, the Foundation processed \$2,159,661 of charitable contributions to our 107 named funds.
